

TERMS AND CONDITIONS

2023 WORLD DORWNING PREVENTION DAY COLOURING COMPETITION & SHORT STORY COMPETITION

STANDARD TERMS

- 1. Information on how to enter and the prizes form part of these Terms and Conditions. Participation in this promotion deems acceptance of these Terms and Conditions.
- 2. The Promoter is Royal Life Saving Society Queensland (ABN 60 478 008 791) of 1204 New Cleveland Road, Gumdale, will be referred as RLSSQ.

WHO CAN ENTER

- 1. Entry is only open to residents within Australia.
- 2. Entry is available to certain age groups from five years of age to sixteen years of age. RLSSQ may require evidence of age and indemnity.
- 3. Employees of the Promoter including but not limited to RLSSQ staff and contractors are ineligible to enter.

HOW TO ENTER
